

2009-2010 Season PSSC Parent/Guardian Membership Agreement

Basic Membership Terms & Understandings:

1. Be actively involved in the support and development of my swimmer and the team.
2. To abide by all other rules of PSSC as they are provided in writing.
3. Bring any questions or concerns directly to the attention of the Head Coach and/or Board of Directors.
4. Provide **written notification of discontinuing membership or other account changes** to the Treasurer **PRIOR TO** the next monthly billing, which occurs on the 21st of the month. *Notifications to PSSC received on or after the 21st of the previous month will take effect the following month and all fees charged during the month of notification shall remain.* Verbal notifications shall not be accepted under any circumstances. Email to the Treasurer is acceptable written notification.
5. If a swimmer discontinues training and competition for more than 2 consecutive months without payment of membership, the administration fee of \$25 will apply per swimmer when the swimmer resumes membership.
6. Understand that Safety is a priority and for this reason, agree to:
 - A. Only USA registered athletes are allowed on deck (excluding USA registered non-athletes) for all practices and swim meets. Siblings and relatives of athletes are not to be on deck at any time.
 - B. Drop off and pick up of athletes for practices should be within 15 minutes as PSSC, SKHS and the pool are not responsible. This is important as the pool may not be open before 15 minutes prior to practice and no supervision is present.
 - C. Children who are not registered athletes must be supervised by their parents and not allowed play or run on deck, in locker rooms or in the timing booth. The best place for all spectators is in the bleachers.
 - D. No distracting coaches from their duties; they must be able to work and watch athletes without interruptions and distractions. Should you need to speak to a coach, do so before practice commences or after practice is completed.
 - E. Fire Zone areas of the parking lot are not for parking; pick-up and drop off stops are allowed and vehicles must be attended. Parking in Fire Zones is illegal and adds to congestion and safety concerns.

Basic Financial Terms of Membership:

7. REGISTRATION FEES:
 - A. ANNUAL PSSC ADMINISTRATION FEE: of \$25.00 will be charged to your account. **Note:** *If a swimmer discontinues membership for more than 2 consecutive months during the swim year without payment of membership, the Administration Fee of \$25 will reapply per swimmer when the swimmer resumes training and/or competition.*
 - B. USA SWIMMING ATHLETE REGISTRATION FEE: \$61.00 per athlete for the 2009-2010 year.
8. MONTHLY TRAINING DUES: are established by the PSSC Board of Directors and the costs for each training group are posted on the PSSC website. These are billed to your account per Item #4 above.
9. LATE PAYMENT FEE: Pay all monthly dues and monthly training fees by the 15th of each month. I recognize a late payment fee of \$10.00 may be assessed for late payments. *No prorating for partial months.*
10. "NSF" CHARGES: will incur an additional \$25.00 fee for each occurrence.

11. MONTHLY STATEMENTS: will be sent via email on the 21st of the previous month; any requests for a hard copy to be mailed to my address will be charged a fee of \$5.00 per mailing.
12. PAST DUE ACCOUNTS LATE PAYMENT POLICY:
- A. 30 days late, member will receive an email from treasurer requesting time and date of outstanding amounts. No purchases will be allowed to members account for such things as swim gear or concessions at PSSC hosted meets if members' accounts are 30 days late or more.
 - B. 60 days late, swimmer is suspended from signing up and attending swim meets.
 - C. 90 days late, swimmer will be barred from attending training practices. All privileges will be restored, at the time payment is made to treasurer to make members' account current.
13. FUNDRAISING: Participate in the PSSC Swim Marathon Fundraiser and/or Sponsorships, either by collecting pledges or making a donation in the event of a scheduling conflict that prohibits direct participation. *In the event I do not participate, I understand that PSSC shall invoice the stated amount in Table 1 of this agreement. The fee will be assessed after the Swim Marathon takes place.*
14. VOLUNTEER SERVICE FOR ALL HOME MEETS: The family minimum commitment varies by training group and are stated in Table 1 of this agreement. The number of meets PSSC has been awarded to host for the 2009-2010 swim year is four. The dates of these meets is contained in the PSSC Meet Schedule on the team website (swimPSSC.org)
- A. Positions available sign-up sheet will be posted on the PSSC website, prior to each hosted swim meet which offers me choices on how to help and sign-up for. Click on Job Signup under each listed PSSC home meet description.
 - B. I understand that *PSSC will charge an assessment to my monthly account in the amount of \$50.00 per session for not satisfying the minimum commitment on each PSSC hosted meet.*
 - C. In case circumstances do not allow the member family to meet their volunteer commitment, arrangements must be made PRIOR to the meet with the PSSC President. All cases will be reviewed on a case-by-case basis. In order for your special circumstance to be considered, other arrangements MAY be allowed only if communicated PRIOR to the swim meet.
15. HIGH SCHOOL FITNESS: If a swimmer is paying monthly dues as a High School Fitness swimmer, that he/she will abide by the M/W/F only schedule, which does not include Saturday practices or dryland workouts after practice. If a high school fitness swimmer substitutes days or adds additional practices, an additional \$15 fee will apply per occurrence.

I hereby acknowledge and accept the obligations and requirements of membership as stated by PSSC in this agreement.
